PASS

<p>P</p>	<p><u>PULL</u> the pin, this unlocks the lever and allows you to discharge the extinguisher</p>	
<p>A</p>	<p><u>AIM</u> low: point the extinguisher nozzle (or hose) at the base of the fire</p>	
<p>S</p>	<p><u>SQUEEZE</u> the lever above the handle: this discharges the extinguishing agent</p>	
<p>S</p>	<p><u>SWEEP</u> from side to side moving carefully toward the fire</p>
